### VOLUNTARY PREKINDERGARTEN (VPK)

VPK students at MGRI receive instruction at no additional cost during the academic hours of **8:30am-11:30am**. VPK Wrap-around tuition applies for families interested in enrolling the student for a full day or extended day schedule.

#### **PAYMENT INFORMATION**

**Enrollment Deposit:** For new families, a non-refundable deposit consisting of the registration and material fee are due upon acceptance of student to formally secure enrollment. Returning families must pay the annual student material fee by **July 1st** to secure enrollment for new school year. If returning student is a recipient of a scholarship that provides funding for school fees, all necessary scholarship information must be submitted to MGRI admissions and accounting no later than **July 1st** to secure enrollment. If deposit or scholarship information is not received by the deadline, returning student is not guaranteed enrollment for the new school year. **Sibling Discounts:** A tuition discount of 10% will apply to the oldest sibling and a 5% discount will apply to each additional sibling.

**Payment Methods:** Payment is accepted by credit or debit card, Zelle bank transfer, or check. All families, including scholarship and VPK recipients, must have a valid credit or debit card on file. A 3.5% convenience fee will be applied to all invoices (due 8/01/2022 or later) paid with a credit or debit card. Cash payment is not accepted.

**Payment Plan Options:** MGRI offers three tuition payment plan options.

- **Payment in Full:** Total tuition balance, less a 5% discount, due by August 1st of the school year
- **Two Payments:** Two equal payments of the total tuition balance, less a 2.5% discount, due on August 1st and January 1st of the school year
- **Monthly Payments:** Ten equal monthly payments of the total tuition balance due on the 1st of every month, August-May, of the school year

**Late Payment Fee:** A \$50 late fee will apply to invoices if payment is not received by close of business on the 5th business day following the invoice due date. An additional \$25 late fee will apply to invoices every five (5) business days without payment. A \$50 fee will apply to returned checks. After 30 days of no payment or establishment of a payment plan, student will not be accepted at drop off.

**Step Up For Students-Unique Abilities:** Additional academic fees may be assessed according to the need level indicated per the scholarship award – up to the full amount of the award.

**Tuition Obligations:** Customer understands and agrees that the student is enrolled for an entire academic year, and the customer is liable for the entire year's tuition payment upon the signing of the Enrollment Contract. If thereafter the student is withdrawn, or absent for any reason, MGRI will not refund any amounts paid and the customer remains responsible for the entire year's tuition and fees. Tuition obligation will be waived if expulsion or termination is initiated by MGRI, and any prepaid tuition beyond that month will be refunded. Note that tuition applies to maintain your child's enrollment regardless of attendance or absences, whether due to illness, vacation, or holidays. Tuition categories are guided by chronological age but determined by developmental characteristics. Consistent toileting ability is required for acceptance into the primary program. Failure to pay tuition in a timely manner, does not relieve the customer of the responsibility for payment of the entire year's financial obligations. Similarly, the customer remains solely responsible for payment of all financial obligations, regardless of whether the customer depends upon or anticipates other sources for funding. If the Student is a scholarship recipient, and the funding does not meet 100% of the tuition and fees obligations, the customer is liable for the differential. Customer is responsible for all legal and collection fees if such actions are necessary by MGRI to obtain outstanding tuition. MGRI reserves the right to change tuition, fees, and program hours. Note that payments are eligible for Federal Child and Dependent Care Tax Credit (CDCTC). Federal tax ID #: 454920620.
